Multi-Site Institutional Research¹

(<u>multi-site</u> research sponsored by UCCCC investigator and/or coordinated by the UCCCC CTSO)

Start Up Support Fee²:

The Quality Unit supports Investigator Initiated Trials with start-up services which include; protocol editing, site activation readiness, site initiation presentation, lab manual preparation, database build, multi-site communication prior to activation.

Registration Review Annual Maintenance Fee³:

The Quality Unit will support Investigator Initiated Trials by review of each patient's consenting process, and eligibility criteria.

Data Monitoring and Multisite Coordination Annual Maintenance Fee:

The Quality Unit will support Investigator Initiated Trials by conducting reviews of data entered into the trial's database. The data review includes completion of data and data quality. Monitoring findings are documented in monitoring reports.

Data Monitoring and Multisite Coordination (when all subjects in Follow Up) Annual Maintenance Fee:

The Quality Unit will support Investigator Initiated Trials by conducting reviews of data entered into the trial's database. Trials with all patients in long-term follow up will be invoiced a distinct fee. Reflecting the nature of limited data to be reviewed.

Data Monitoring All Patients in Long term Follow Up \$2,000

Legend

- 1. Single-Site Trials will not be charge a Quality Unit Fee during the FY24 period. Network sites, such as Silver Cross and Orland Park are not considered externals sites.
- 2. Start Up Fee will be invoiced after the protocol is activated as open to accrual.
- 3. Registration Fee will be initially invoiced 6 months after the trial has been open to accrual.
- 4. Monitoring and Data Coordination Fee will be initially invoiced 6 months after the trial has been open to accrual.
